# Step 1: Read the Question and the Historical Background

- What is the question asking you to do?
- What is the verb in the question?
  - Ex: "Analyze"
- What is the object of the verb?
  - Analyze what?
  - When?
  - Where?
- Sample Question:
  - Analyze the development of Riverdale/Kingsbridge Academy between 2010 and 2013.

#### Step 2: Analyze the Evidence

#### Questions you should be asking:

- What is the **basic meaning** of the document?
- How can I use this document to answer the question? What other documents can I use to answer the question in a similar way?
- Who is the author ? Who is the author's intended audience? What is the intended outcome? What is the tone?
- Is there some other information that would help 'flesh out' the evidence in this document?

#### Step 2: Analyze the Evidence (cont.)

- You may want to develop a uniform notetaking technique that will help you find information later
- Example:



### Step 3: Planning Your Thesis

- Decide on 2 or 3 different main points that encompass all of the documents
- Decide which documents will be used for which main points
- You may want to do this using graphics:



#### Step 3: Planning Your Thesis (cont.)

- But... what if one document doesn't 'fit' your main points?
- Do Not:
  - Leave out the document!
- <u>Do:</u>
  - Create another main idea for that one document; or
  - Make it fit!
    - Find a place where it fits best and `stretch' it's meaning in order to make it support one of your main points

#### **Step 4: Write Your Thesis**

- Limit yourself to one background sentence
- Write one sentence for each main point:
  - Main Point #1
  - Main Point #2
  - Main Point #3
- Don't mention the documents yet!

#### Steps 5-9: The Body Paragraphs

#### **Step 5: The Topic Sentence**

- Restate one of your Main Points and identify which documents you will use to support it.
- Example: "RKA's progress in athletics during this period is evident in documents 2, 5, 7, & 9."

## G is for GROUPING!



### **Step 6: Basic Understanding**

- Show a basic understanding of your first document (one sentence only)
- Example: "Document 2 is a photograph of a championship banner hanging in the gym."

## B is for Basic Understanding!





#### Step 7: Support the Thesis

 Explain how this document supports Main Point #1

SCARE

Example: "This shows that the school reached a level of excellence in baseball in 2011."

# S is for Support!



#### Step 8: Analyze Point of View

Identify the author & analyze his or her *intended audience* and/or *intended outcome* and/or *tone*.
Example: "The athletic director created this *banner. He wishes to display the achievements to everyone who walks into the gym."*

## P is for Point of View

**PFOPIF** 



#### **Repeat Steps 6-8**

- Repeat steps 6-8 for each document in this group
- It's OK you don't have POV for each

#### **Step 9: Additional Document**

- Identify an additional document that would help you further support your main point
- Example: "A quote from a student-athlete would help evaluate the impact of RKA athletics. This would offer a firsthand account of how sports directly affect students' educational experiences."
